#### Admission

The Bridges Academy program is exclusively for children with average or above average intelligence who have specific learning differences such as Dyslexia, Dysgraphia, Dyscalculia, ADHD, ADD and HFA. For consideration of admission, a diagnostic testing report is required and/or a doctor's letter. We may request diagnostic testing if testing is outdated or incomplete.

Once all test results have been examined; an interview and a visit to the school will finalize admission.

# Important: Students whose primary diagnosis is an emotional or behavioral disorder; Bridges Academy may not be able to meet the child's needs.

#### **Tuition and Fees**

Enrollment/Registration/Testing Fee: is separate from tuition and is non-refundable

#### Tuition: Changes yearly

Payment is due before the 10<sup>th</sup> of each month. Bridges Academy will enforce board policies regarding late payments and returned checks. There will be a \$25 charge for late payment and/or returned check.

Bridges Academy reserves the right to withhold grades, report cards, transcripts and/or diplomas for nonpayment of tuition and fees. Students may be suspended for nonpayment during the school year.

#### **Tuition Assistance**

Tuition Assistance is limited and requires parents to submit your 1040 and W-2 for the previous year. Tuition Assistance will be discontinued for nonpayment and for excessive absences and tardy days.

The IRS has ruled that tuition to schools like Bridges Academy is a medical expense. Check with your account to see if you qualify. This also includes transportation expenses.

A letter from the child's doctor recommending Bridges Academy has a neurological disorder. IRS Revenue Ruling 78-340, 1978-2 C.B. 124

Funds are limited for tuition assistance and first come/first served.

### Students' Pick-up and Drop Off

Bridges Academy is not responsible for students before 8:00am and after 3:30

## <u>Absences</u>

The state of Texas requires that students be in attendance 90% of scheduled instructional days. (TAC Section 25.085) A parent commits an offense if the student does not attend the required number of days and may be prosecuted in a Justice of the Peace Court.

An exception to attendance policy must be approved by Bridges Academy.

Call the office by 9:00am to receive an excused absence.

## <u>Tardiness</u>

A student is considered tardy by 8:20am. Students must pick up an "admit slip" in the school office before proceeding to class. Please call the office to excuse the tardy.

### Early Pick-up

If your child must leave during the school day for a medical appointment or other commitments, please let us know AHEAD of time. This will allow teachers to prepare any work that needs to be sent home. Parents must report to the office before picking up the student for any appointment.

## Make-up Work

School work missed during absences must be made up within the same length of time, i.e., if a student is absent 2 days, he/she has 2 days to make up work. Work can be made up for excused absences only. Please call-in absences by 9:00am to receive an excused absence.

## **Suspension**

Students who are suspended will receive unexcused absences but will still be required to complete assigned work. Work not turned in will receive "zeros". Teachers will determine what work will be assigned and when it must have to be turned in.

Bridges will close when the 3 major school districts close. Parents will receive an email and an announcement will be made on local television stations.

#### **Report Cards/Grades/Progress Reports**

Report cards are given out every 9 weeks. The dates are listed on the school calendar. Progress reports are sent out after the 4<sup>th</sup> week of the 9-week period.

#### Grades: 1st-2nd

Students' grades are based partly on effort, neatness, improvement and correctness of work.

E-Excellent	90-100
S-Satisfactory	80-89
N-Needs improvement	70-79
U-Unsatisfactory	69 and Below

#### Grades 3rd-9th

Students' grades are based equally on classwork, homework, tests and special assignments. Some special assignments may count for a greater percentage of the 9-week grading period.

#### **Forgotten Lunches**

When your child forgets his/her lunch, we will provide lunch from the snack bar and invoice your account if the student is authorized to charge. Students will not be allowed to call parents for forgotten lunches. Please do not bring fast food lunch for your child. Please remember to provide lunch and a snack daily. **No sodas or candy.**  **Behavior Plan:** The following behaviors are characteristics that our students display. This plan is to help students recognize and change behaviors that get them negative results.

I.	Interrupting the class lesson/teacher
	Interrupting when others are speaking
С	Lack of Consideration: some student behavior can appear to be
	Rude or inconsiderate and often happens because our students are
	Impulsive and do not judge the social situation correctly
R	Lack of Responsibility: forgetting homework or coming to class
	Without school supplies needed for that class; forgetting PE
	Clothes and not complying to uniform dress standards
	In general, anything that is his/her responsibility
N	Not attending to class lesson

# 4 demerits in one day results in a Major Demerit and the student cannot order takeout food on Thursdays. This restriction is only for the current week.

Also, the student may not order takeout food on Thursday if he/she has 2 days with demerits in 5 school days. Merit/demerit week runs from Thursday-Wednesday.

Teachers will be given specific information on which restaurants are chosen with specific food items that can be ordered and cost.

**Student Contract:** Some students may need to change certain behaviors that require a personalized behavior plan. The contract focuses on no more than 3 behaviors.

#### **Major Demerits:**

- Throwing rocks
- Pushing/hitting another student
- Profanity
- Stealing
- Leaving School Grounds
- Bullying/Harassment

### **Major Demerits Consequences**

1 <sup>st</sup> -3 <sup>rd</sup> Grade	1 day of refocus/no PE and no Recess
4 <sup>th</sup> -6 <sup>th</sup> Grade	3 days of refocus/no PE and no Recess
7 <sup>th</sup> -9 <sup>th</sup> Grade	3 days of refocus/ no PE and no Recess (Refocus is near the teacher's desk. Students will attend scheduled classes.

## Parents will be notified of any major demerits and, if necessary, a parent conference will be scheduled.

#### **Reason for Dismissal:**

Excessive absences or tardiness

Consistently fails to complete school work/homework

Failure to pay tuition in a timely matter

#### Suspension

Any Major Demerit may result in a 3 days of suspension. Student will be

given school work and failure to return assigned school work will result in a 0(Zero) for every missed assignment.

#### Expulsion: Violent Behavior

Drugs or weapons

#### By Law, police must be notified.

#### **Use of Electronics**

- With teacher's permission
- For use as an accommodation for school work
- Inappropriate use of electronics: school will retain electronic for 3 days

#### Lunches/Snacks

- Students must bring lunch Monday-Thursday
- Students must bring lunch on Friday if participating in Robotics or Lego Team
- Students may order takeout food on Thursday. Students must pay for ordered food. (Check behavior plan)
- Parents will be notified if your child has earned the privilege to order takeout food on Thursday.
- Students must bring a snack Monday-Friday
- Forgotten Lunches: Students are not allowed to call parents if they forget their lunches. Students will be allowed to charge for lunch from the snack store when approved by the parents. Please do not provide fast food at any time.
